## **Investment of Public Funds Report**

The Department holds investments at State of Illinois chartered deposit institutions as operating accounts for various programs under the control of the Department.

The information has not been subject to any audit and is not intended to be a presentation in conformity to Generally Accepted Accounting Principles.
