Mare must remain continuously in and foal in Illinois. **Mare must be a public auction purchase and 100% Illinois owned. Mare may be inspected by a Departmental investigator.**

An Application for Foal Registration will be mailed to the person in charge of the mare at the foaling location. The Application for Foal Registration must be filed with the Department of Agriculture within ten (10) days after foaling. The foal must be identified by a Departmental investigator or approval given before the foal can leave the state.
