LIST OF ELIGIBLES

EQUIPMENT PURCHASES & REPAIRS/MAINTENANCE

TO BE ELIGIBLE: *All must be utilized for fair business and stored on fairgrounds unless otherwise requested in writing by fair president and approved by IDOA county fair office (i.e., off-season, security purposes, etc.).*

LABOR ON GROUNDS

Effective July 1, 2011 (FY12), donated labor is eligible ONLY as matching funds or cost share for reimbursement described in the Act. If Donated Labor is NOT labeled as such, it will NOT be considered as match/cost share.

SIGNED LABOR RECEIPTS (SUPPLIED BY THIS OFFICE) SHALL INCLUDE:

NAME, ADDRESS, SPECIFIC TYPES OF LABOR RENDERED, AND AMOUNT(S).

MUST SPECIFY TYPE OF LABOR: i.e., mowing, types of repairs, types of maintenance, donated labor, etc.

IF LABOR IS not SPECIFIED/DESCRIBED other than GEN MAINTENANCE/LABOR, IT WILL not BE CONSIDERED FOR CREDIT.

CASUALTY & LIABILITY INSURANCE *(including Workmen's Comp.)*

PERSONAL LIABILITY (i.e., Director's Insurance.)—NOT ELIGIBLE.

(Eff. FY06: MAXIMUM \$20,000.)

CONSTRUCTION OR PURCHASE OF PERMANENT FACILITIES & SYSTEMS STORED ON FAIRGROUNDS

INTEREST ON LOANS

(ELIGIBLE IF THE LOAN IS FOR BUILDING PROJECTS, REPAIRS, REAL ESTATE, OR ELIGIBLE FACILITIES & SYSTEMS. (OPERATING LOANS ARE **NOT** ELIGIBLE.)

BUILDING MATERIALS/SUPPLIES

(OFFICE/CLEANING SUPPLIES: NOT ELIGIBLE unless otherwise approved by IDOA County Fair Office.)

***Unless otherwise approved by IDOA County Fair Office for eligible rehabilitation purposes, the following**

EQUIPMENT and/or LABOR are NOT ELIGIBLE:

- OFFICE/KITCHEN HELP OR OFFICE/KITCHEN EQUIPMENT/APPLIANCES;
- OPERATIONAL LABOR INCLUDING CLEANUP (i.e.; setting up/tearing down prior to and following the fair);
- CLEANING, MANURE/SNOW REMOVAL/EQUIPMENT and/or GARBAGE REMOVAL (Eligible if clean-up includes, i.e.: torn down building, storm damage debris, etc.); and
- EQUIPMENT RENTALS (Eligible if equipment is used for eligible ***SPECIFIED/DESCRIBED*** maintenance/construction projects listed above).
