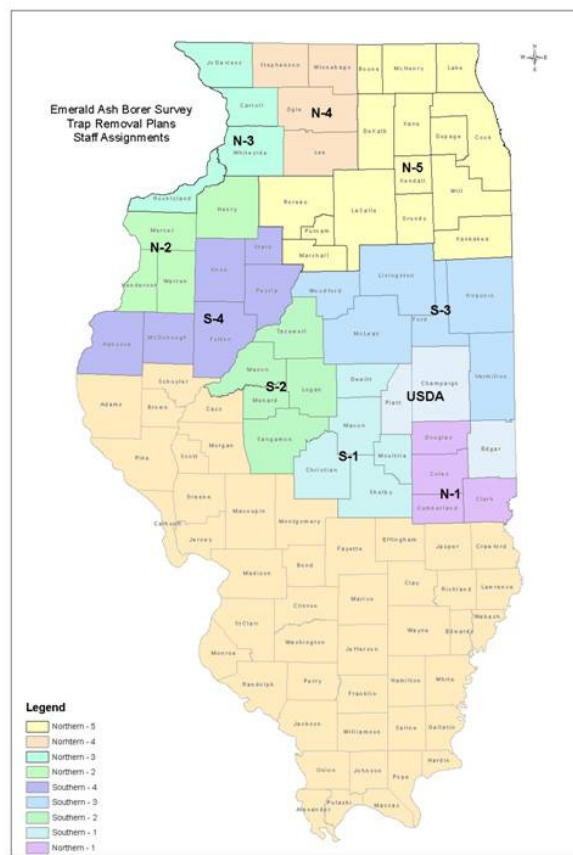
Trap Harvesting has Begun

On April 5, IDA officials began the annual EAB trap deployment, hanging the gooey, sticky, purple traps every 1.5 square miles in ash trees within the priority grid zone just outside the Illinois EAB quarantine boundaries. There were 6,325 EAB purple “sticky” traps deployed state-wide by IDA, USDA-APHIS, and various municipal partners.

Trap harvest began July 26. Existing nursery and pesticide field staff members are harvesting traps scattered through southern Illinois adjacent to high risk sites such as parks and campgrounds while the contractual workers headquartered in Springfield began trap removal in DeWitt, Macon, Christian, Shelby, and Moultrie Counties. Both groups are transporting harvested traps to the Springfield office for processing by two experienced EAB permanent field staff members. The balance of the EAB field staff began trap harvest the following week in Douglas, Coles, Cumberland, and Clark Counties and are processing the traps in the



field rather than transporting them to Springfield. A map of the trap harvest/removal staff assignments follows with the Springfield staff identified by S-1, S-2, S-3, and S4 and the DeKalb-headquartered staff identified as N-1, N-2, N-3, N-4, and N-5. The number following the letter indicates the order of trap harvest.



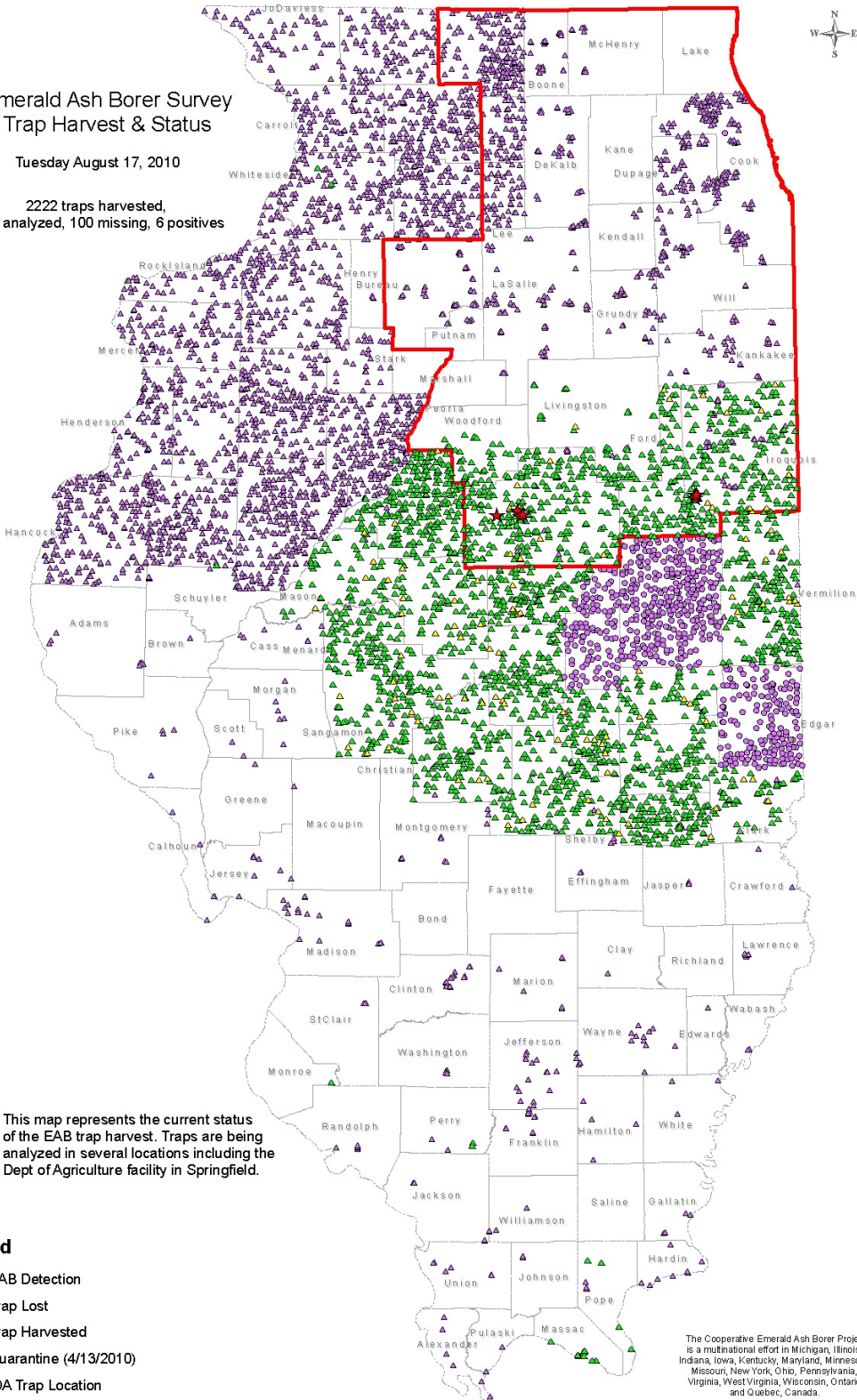
Prior to harvesting, IDA contractual workers had been focusing their efforts on outreach activities in central and southern Illinois. Preparing and delivering packets of EAB information, including various informational brochures and firewood posters as well as some promotional items such as re-useable grocery bags, ink pens and envelope openers to cities and towns located throughout the grid-trapping area. More than 70 municipalities and/or state park facilities in central and eastern Illinois were visited in July. In addition, IDA staff members in both central and northern Illinois responded to a limited number of reports of “downed” traps as a result of the summer’s storms and high winds.

STATE AND FEDERAL EAB QUARANTINES—HOW WILL THEY AFFECT YOU?

FIND OUT AT AN EAB HOMEOWNER MANAGEMENT WORKSHOP!

EAB is a small, metallic green beetle native to Asia. Discovered in Illinois in 2006, it has since spread throughout northeast Illinois and remote locations in east central Illinois. EAB feeds only on true Ash trees. If trees go untreated, the death rate is 100 percent. If infested trees are not treated or removed, EAB will continue its destructive path moving on to other ash trees—eventually wiping out all Ash trees.

EAB—how did it get here and what can we do? Dr. Phil Nixon, University of Illinois Extension entomologist will explain the history, life cycle and control options for EAB. Session topics include:

- EAB look-alikes
- Ash tree identification
- Ash tree and ash wood disposal
- Recommended ash tree replacements
- Firewood movement and quarantine restrictions

There is no fee to attend, but reservations are required for all locations. To register, contact the University of Illinois Extension office serving as host for the event.

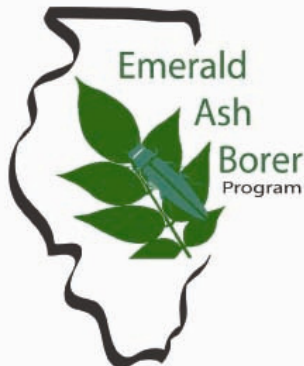

State Law Requires ALL FIREWOOD IMPORTERS to register with IDA.

To help stop the spread of these destructive pests, the IDA recommends that this entire bundle be consumed prior to May 1.

You can help slow the spread of various insect pests and plant diseases by not moving firewood.

It is a violation of Federal and State Law to move firewood across the state line!

If you are camping, the IDA recommends you do not carry any unused firewood with you to your next destination. Instead, IDA recommends that you burn all firewood before you leave the campsite.
